



#### PERFORMANCE

#### ALL TOROUE ALL ACTION

Befitting of its Gazoo Racing badging, the GR86 has been manufactured to deliver maximum performance on both the road and the track.

Its new, larger capacity, naturally aspirated 2.4ℓ flat-four petrol engine produces 174 kW @ 7 000 r/min and 250 Nm peak torque @ 3 700 r/min. Its D4-S dual-injection fuel system, comprising both direct and port injection, has been retuned to deliver a more aggressive throttle response.

Sharper, stronger suspension, a low centre of gravity and a near-perfect 53/47 front/rear weight distribution all contribute to the GR86's precision handling: the very essence of unadulterated driving exhilaration. Plus, a torque-sensing limited-slip rear differential keeps you in control at all times. Furthermore, the GR86 is one of the lightest sports cars on the market which is perfect for beating the stopwatch and getting your pulse racing.

#### The all-new GR86 delivers thrills around every corner.

Its silhouette has been honed for a sharper, faster, more aerodynamic profile, and several motorsport-derived devices added to increase stability and create cleaner airflow. At the front, the GR-specific G-mesh grille exudes aggression. The grille is shouldered by full LED headlights equipped with adaptive cornering technology, as well as an Auto High Beam\* function that automatically switches between high and low beams when oncoming traffic is detected.

### Underlining the GR86's thoroughbred credentials is the proud placement of GR badges on the front grille and boot lid.

Similar to Toyota's Le Mans-winning endurance race cars, to reduce drag, lift and add steering stability, the GR86 features air outlets behind the front wheels to allow air trapped in the wheel arch to escape. Specially mounted fins correspondingly condition airflow around the rear wheel arches. The GR86 also features lightweight, matte black, innovatively-styled 18" alloy wheels to make sure you look good while you're going fast.

The GR86 is designed to be driven by someone who loves driving.

#### WELCOME TO THE DRIVER'S SEAT

The GR86's interior has been crafted to feel like a classic sports car, featuring enhanced dynamics that evoke a pure driving performance. The silver-stitched sports seats are dressed in a combination of leather and suede, which apart from being breathable, grip occupants during cornering and braking. To complement the sporty, all-black interior adorned with silver accents, exclusive GR badges appear on the steering wheel, Push Start button and Smart Key (that enables keyless entry and exit).

Smartphones can be paired either via Apple CarPlay or Android Auto, and their contents displayed on the high-resolution 7" multi-information display. This screen also acts as the monitor for the GR86's reverse camera.

Finally, to enhance professional track activity – and excitement – when selected, the custom-designed Track Mode combination meter displays a shift indicator, oil and water temperatures and a lap timer.

Although the GR86 is made to deliver you an incredible driving experience, its athleticism does not come at the cost of safety.

The GR86 is fitted with an extensive suite of safety features.

Standard equipment includes Anti-lock Brakes (ABS) with Electronic Brake Force Distribution (EBD), Brake Assist (BA), switchable Traction and Vehicle Stability Control (TSC and VSC), Hill Start Assist Control (HAC) and an Emergency Brake Signal System (EBS).

Both models are fitted with Toyota's comprehensive Safety Sense package that offers additional protective emergency countermeasures.

These include: a Pre-Crash System that warns the driver of rapidly approaching vehicles and other objects. Upon detection, emergency braking and safety belt bracing is activated to avoid or mitigate impact without driver input.

The Lane Keeping System with Lane Departure Alert detects lane markers and the edge of the road and where the vehicle is in relation to the lane. When deviation takes place, the driver is alerted. The vehicle's brakes will then automatically endeavour to arrest any further departure from the lane.

Rear Cross Traffic Alert (RCTA) and the Blind Spot Monitor (BSM) will warn the driver of unseen objects behind the vehicle during lane changing manoeuvres, and when reversing into perpendicular flowing traffic. RCTA works in conjunction with the GR86's Rear Park Distance Control.

All models are fitted with an alarm and immobiliser, and for further peace of mind the doors lock automatically when the vehicle pulls away.
